4. SECTION 4: FIRST AID MEASURES



4.1 Description of first aid measures

Inhalation	Remove persons affected by vapour to fresh air. For those providing assistance, avoid exposure to yourself or others. If respiratory irritation, dizziness, nausea, or unconsciousness occurs, seek immediate medical assistance.
